ADFACT's Sober Driver Program is a nine-week course, comprising two contact hours each week.

Who is ADFACT's Sober Driver Program for?

Anyone who is:

- Yet to go to court for drink driving offences
- Seeking licence restoration
- Directed by courts or Corrective Services
- Concerned with the hazards of drinking and driving

ADFACT's Sober Driver Program provides...

- Confirmation of enrolment for courts and requests for adjournment until after graduation
- Information on the legal aspects and health and social impacts of drink driving
- Standard drink & safe drinking information/strategies and stress management techniques
- Advice on special licences
- Referrals to treatment or other appropriate agencies

ADFACT's Sober Driver Program aims to...

- Provide participants with accurate information about drink driving and safe drinking levels
- Assist participants in the development of positive personal skills and attitudes in regard to alcohol and drink driving issues
- Engage offenders in an education program that targets the prevention of drink driving and the avoidance of health risks from harmful levels of alcohol consumption

Part B – Declaration

I declare that I accept the following conditions of acceptance into the program and agree to:

1. Pay the program fees of \$450 or \$300 for Healthcare Card holders
2. Attend each of the nine weekly sessions of the program
3. Be alcohol and drug free when attending the program
4. Be breathalysed before or during a session, either at random or for cause
5. Notify the ADFACT office of any of the following: *change of address, change of employment, inability to attend a session (providing support evidence if for sickness or work commitments), inability to pay the fees at the agreed rate*
6. Accept the program rules concerning attendance and participation in program activities, including homework
7. Relevant information being shared with courts, solicitors and referring agencies including enrolment, graduation certificate, breaches of the program rules
8. Allow data collected to be used for statistical/research purposes, without name identification
9. Be interviewed at a mutually convenient time and place sometime after the program
10. The attendance of students at session for training purposes
